Q: IF I WORK FOR ANOTHER COMPANY WITHIN MM&P DOES MY VESTING PERIOD RESTART FOR ANY OF THE PLANS THAT I AM ENTITLED TO AS PART OF MY COLLECTIVE BARGAINING AGREEMENT?

A: NO, ALL OF OUR PLANS OPERATE UNDER A TRUST AGREEMENT. YOUR PLANS CONTRIBUTIONS FOLLOW YOU TO ALL OF THE EMPLOYERS THAT YOU MAY WORK FOR UNDER MM&P CONTRACT. THE VESTING PERIODS REMAIN THE SAME REGARDLESS OF WHAT CONTRACT YOU ARE WORKING ON.

Q: DOES MM&P HAVE LICENSE INSURANCE?
