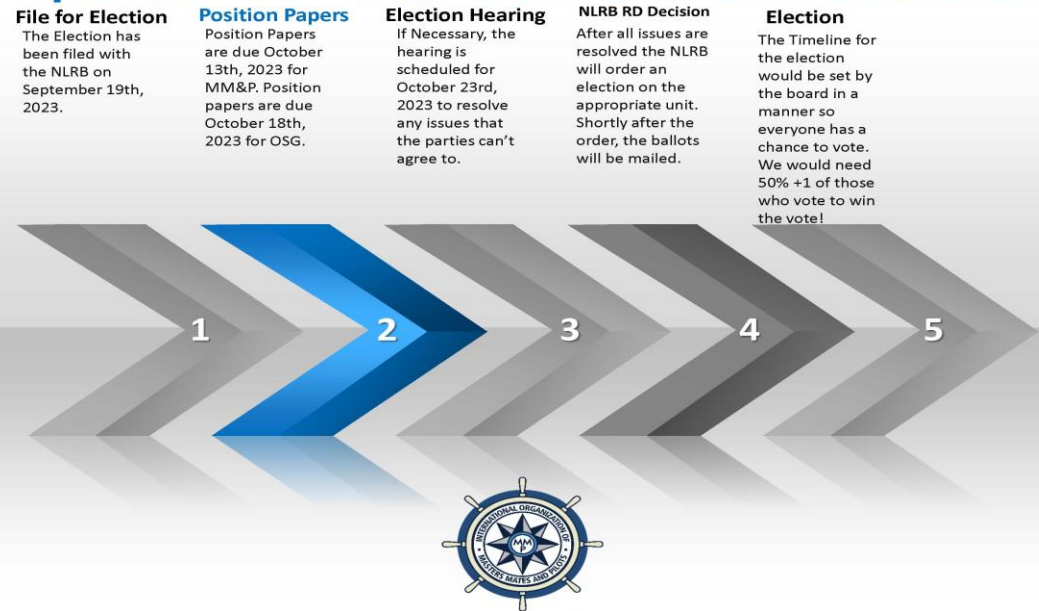

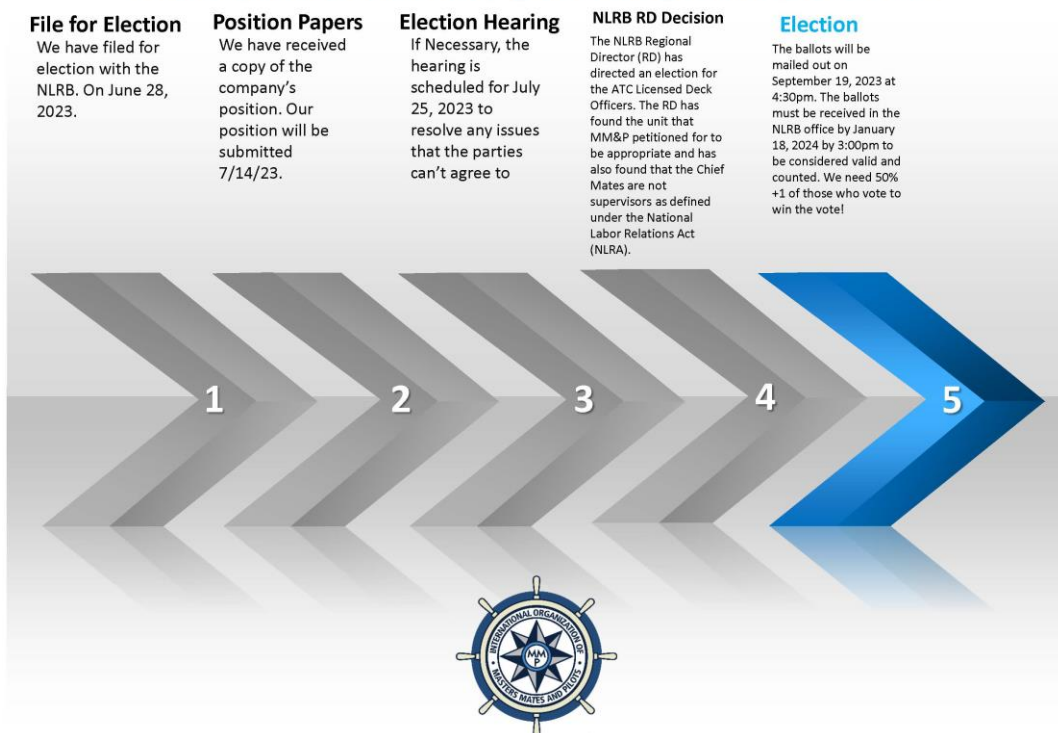

## FAQ:

**Q:** I HAVE A QUESTION REGARDING THE UNIONIZATION OF ATC/OSG. ASSUMING WE VOTE FOR MM&P REPRESENTATION, WHAT KEEPS OSG FROM GOING TO ANOTHER UNION FOR A CONTRACT FOR LICENSED DECK OFFICERS?

**A:** THE NATIONAL LABOR RELATIONS ACT MAKES IT UNLAWFUL FOR THE COMPANY TO CHANGE TO ANOTHER LABOR SOURCE TO AVOID MM&P OR TO FRUSTRATE YOUR CHOICE OF MM&P AS REPRESENTATIVE. ANY EMPLOYEE WHO IS LET GO UNDER SUCH A SCHEME WOULD BE ENTITLED TO GET HIS/HER/THEIR JOB BACK WITH BACKPAY AND OTHER DAMAGES.
