ATC FLEET AND OSG FLEET UPDATE



FORTY-ONE DAYS UNTIL THE BALLOTS ARE COUNTED FOR THE ATC FLEET LDOs. WE ARE STILL WAITING FOR AN ELECTION ORDER FROM THE NLRB FOR THE OSG FLEET LDOs. ESSENTIALLY THE SAME ELECTION WAS ORDERED FOR THE ATC LDOs IN ROUGHLY TWO WEEKS. WE HAVE BEEN WAITING 46 DAYS FOR THE TAMPA NLRB TO COME OUT WITH A DECISION. WE ARE ALL FRUSTRATED WITH HOW LONG THE PROCESS IS TAKING. WE ALL HAD OUR SHARE OF LONG HITCHES AT SEA. RELIEF IS OVERDUE BUT NOT OUT OF SIGHT. CONSIDER WHERE WE STARTED. A FIRST CONTRACT IS ON THE RADAR. WE WILL HAVE OUR SEAT AT THE TABLE.

KNOWING WHAT OUR RAISES WILL BE FROM YEAR TO YEAR IN A BINDING UNION CONTRACT.

- PENALTY COMPENSATION FOR TANK ENTRY AND CLEANING TANKS.
- CREW WI-FI IN A BINDING CONTRACT.
- ENHANCED RETIREMENT OPTIONS.
- THE ABILITY TO NEGOTIATE CHANGES IN WORKING CONDITIONS AND POLICY.
- NOT PAYING OUT OF POCKET FOR CLASSES TO UPGRADE YOUR LICENSE.
- MORE CONTROL OVER SCHEDULES AND DURATION OF TOUR.
- JOB SECURITY AND FIRST-RATE OPPORTUNITIES ELSEWHERE IN THE INDUSTRY
