A DEMAND TO BARGAIN!

THE COMPANY HAD UNTIL THURSDAY JANUARY 26, 2024 TO FILE AN OBJECTION TO THE ATC FLEET LDO BALLOT COUNT. TO DATE NO OBJECTION WAS FILED. WE EXPECT TO GET THE NLRB CERTIFICATION SOON, AFTER WHICH WE WILL MAKE OUR DEMAND TO BARGAIN TO THE COMPANY. IN THE MEANTIME, WE HAD A GREAT MEETING WITH THE ATC LDOs TODAY TO DISCUSS THE NEXT STEPS IN THE BARGAINING PROCESS AND RECEIVE THEIR PRIORITIES FOR OUR CONTRACT. WE HAVE A STRONG, COHESIVE, AND HIGHLY MOTIVATED GROUP OF DECK OFFICERS READY TO BARGAIN. THE BARGAINING PROCESS CAN BE AN ENDURANCE TEST BUT AS LDOs WE ARE ACCUSTOMED TO THE STEADY PACE OF A HITCH OR VOYAGE. THE IMPORTANT PART IS THAT WE ALL MAKE ARRIVAL TOGETHER.

WE LOOK FORWARD TO HAVING PRODUCTIVE AND CONSTRUCTIVE BARGAINING AS WE WORK TOWARDS REACHING A FAIR AND COMPETITIVE AGREEMENT.
