OSG AND ATC FLEET UPDATE

BREAKING NEWS: NLRB AFFIRMS MM&P LDO RIGHTS FOR BOTH ATC AND OSG BARGAINING UNITS!



After two years of appeals and delays, the NLRB – IN AN UNANIMOUS DECISION - has officially denied the Employer's request for review—confirming what we have known from the very beginning. Chief Mates have the right to join a union and collectively bargain, and the democratic elections held among the OSG and ATC LDOs were appropriate and will remain as two separate bargaining units.

It took a decision from the National Labor Relations Board to uphold and enforce the company's obligation to respect your vote. We at MM&P are proud to stand with each of you. You have our full respect and our unwavering commitment as we heave ahead and push toward securing a first contract.

ORDER

The Employer's Request for Review of the Regional Director's Decision and Direction of Election is denied as it raises no substantial issues warranting review.¹

We are immediately renewing our demand to bargain to OSG and ATC. We hope that finally they will honor your decision, as they said at the beginning they would, and meet to bargain in good faith with our OSG and ATC bargaining committees. If they continue to refuse to bargain, we have unfair labor practice charges filed at the NLRB ready to move forward.

Now that the Board has confirmed our units and the right of everyone in those units to be represented by the Union – including the Chief Mates, we will move into the most critical phase: bargaining. LDOs are getting prepared to sit across from the Employer to secure the pay, benefits, protection, and respect we have been talking about for over two years.
